



## PhD position with funding (University Assistant Predoctoral), Department of Contemporary History and RECET, Vienna

The University of Vienna is looking to hire 1 PhD researcher for 3 years within the framework of the ERC-funded project HERESSEE - The History of Feminist Political Thought and Women's Rights Discourses in East Central Europe 1929-2001 at the Department of Contemporary History and the Research Center for the History of Transformations (RECET) from October 1, 2024. The project HERESSEE focuses on women's rights and feminism from the perspective of intellectual history and the history of political thought within the region of East Central Europe. It combines the focus on intellectual women and high-ranked political activists with focusing on women's voices marginalized in more traditional approaches to intellectual histories. (read more)

# INTERVIEW OF THE MONTH by Tina Filipović

Oszkár Roginer-Hofmeister is a project coordinator and analyst at the EUROPEUM Institute for European Policy (<u>read more</u>)





the author of two representative monographs dealing with the cultural production of Hungarian minorities in the (post-)Yugoslav context, can you tell us how did minority authors navigate issues of identity, representation, and audience reception in their work? In what ways was literacy used as a tool for cultural preservation, resistance, or empowerment? Depending on the period, Hungarians sometimes considered themselves a minority, as other perceived them as minorities as well. In the interwar years, under the reign of house Karađorđević, this was the typical case of collective existence. In other periods however,

such as in the mid-to-late phases of Yugoslav socialism, they saw themselves as integral parts of an inclusive, emancipatory, ethnically non-repressive collectivity. The level of public use of language, the administrative apparatus, but also the institutions of higher learning, publishing and mass media of Hungarians in Vojvodina was practically on the level of other federal units. In turn, this enabled a self-perception, similar to the larger ethnicities under the organisational umbrella of Yugoslav socialism.

In your experience, what are the most common pitfalls or limitations in the methodologies used to investigate minority issues?

The most common methodologic error I encountered is the binary and archipelagic logic of 20th century research, which haunts us even today. Binary, as we are unable to think beyond the dual possibilities of majorityminority within one state. Although modern minorities existed across Europe after (and to some degree before) the dissolution of the 19th century empires, the academic tendency to assess them only relative to the surrounding majority forced this social phenomenon into descriptive category. Archipelagic, as we are unable to think beyond the possibility of a minority society as Otherness. As it cannot fit into the ideal of the highly industrialised mono-ethnic nation state, it is simply something 'else' which is also there. Methodologically, this meant singling them out and describing them as atypical remnants of another age or even as exotic social fragment.

## What kind of work do you do at the EUROPEUM Institute for European Policy?

As a project coordinator and analyst, I lead projects related to media in the V4 and the Western Balkans. On average, these are projects related to media freedom, access to information, news media digitalisation, and social media. As I have an insider knowledge in media both as a journalist, but also as a socio-historical researcher, I usually bring know-how to the table, which can connect several areas of interest. Since EUROPEUM Institute for European policy is mostly dealing with EU integration and enlargement, these

projects also revolve around how the structure and resilience of the media landscape can contribute to these developments in the future.

#### As a doctoral student you joined us in Pula twice. How did attending doctoral workshops help you advance your research and further career?

The doctoral workshops and the conference Socialism on the Bench provides an international debate circle for everyone's ideas. Although it is organised by historians (mostly), it also accepts applicants from other disciplines, which enriches the dialogues. It also prevents scholarly sectarianism, and helps the convergence between schools of thought, theories, methodologic approaches and viewpoints in general.
